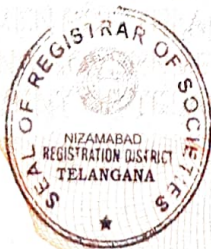


- a) To impart primary, secondary and college education to all in a healthy environment to build strong nation of intellectuals and to promote literacy in our country.

- 4. "Certified that the office bearers signatures are genuine.






3. i) Membership : a) Founder members.

4. GENERAL BODY:

(i) Annual General Body will meet once in a year i.e., in the month of APRIL.


(ii) FUNCTIONS:

- a) To pass the budget for the ensuing year and approve the expenditure statement of previous year.
- b) To approve the report of the activities of the Society.
- c) To Elect the executive committee. Etc.
- d) To appoint the Auditor.

5) (i) The exact number of the executive body (7) i.e. President, Vice President, General Secretary, Joint Secretary, Treasurer and Two executive committee members.

(ii) The members of the executive committee (Governing body) shall be duty bound to attest the signatures of all the members of newly elected executive committee and to see that the signatures of the out going Governing Body tally with the annual list as listed with the Registrar of societies before 15 days the succeeding month in which election were held.

II. FUNCTIONS OF EXECUTIVE BODY AND OFFICE BEARERS:

1. PRESIDENT:

He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in case a tie in decision making. He can supervise all the branches of the Society.

2. VICE - PRESIDENT:

He shall assist the president in discharging his functions. In the absence of President he will perform the duty of the President as entrusted by the president.

3. SECRETARY:

He is the Chief Executive Officer of the Society and custodian of all records relating to the society and correspondent on behalf of the society. He has to take on record of all the minutes of the society, convene both the Executive Committee and General Body of the society with the permission of the president. He guides the Treasurer in preparing the budget and Expenditure statement to place before the General Body for its approval.

4. JOINT SECRETARY:

He has to do the work entrusted by the executive committee. He has to assist the secretary in discharging his duties. In the absence of the secretary he has to perform the duties of the secretary.

5. TREASURER:

She is responsible for all financial transactions and funds of the society. She has to maintain accounts properly along with the vouchers. She has to prepare the accounts of the society and get the same audited by a Chartered Accountant.

6. OFFICE BEARERS:


They are responsible persons to attend to all such activities of the society which the executive committee entrusts to them.

7. QUORUM:

Half of the total members for General Body meeting and 1/4th for executive committee meeting.

8. FUNDS:

The funds shall be spent only for the attainment of the objects of the society and no portion there of shall be paid or transferred directly or indirectly to any of the members through any means. Further the society can raise the funds in the form of loan from Banks and other Financial Institutions.

9. AMENDMENTS:

No amendment or alternation shall be made in the objects of the association without prior approval of the Commissioner of income tax and unless it is voted by 4/7th of its members present at the special meeting convened for the purpose and confirmed by 2/3rd of the members present at a second special meeting.

10. BANK ACCOUNTS:

President or Secretary are authorized to open the bank accounts in the name of society and president or secretary are further authorized to operate such accounts by their individual signatures.


11. LOANS:

President or Secretary are authorized to raise loans from bank or banks or any other financial institutions with the approval of majority of the members by passing a separate resolution for this purpose. The President and Secretary are further authorized to execute all the required documents for the purpose of raising such loans from banks or other financial institutions and all such executions are binding on the society.

12. WINDING UP:

The Society is irrevocable and in case the society has to be wound up the property and funds of the society that remains after discharging liabilities, if any, shall be transferred or paid to some other institution with similar aims and objects.
